

Handler Discrimination will be run first each day.

Move-Up Transfers between trials WILL be offered. Element move ups will be allowed between Trial 1 and 2 by Move-Up Transfer form.

Details of starting times will be included in the Final confirmation letter.

DOG ELIGIBLE TO ENTER

This trial is open to all dogs SIX (6) months of age or older that are registered with the American Kennel Club or that have AKC Limited Registration, Purebred Alternative Listing/Indefinite Listing Privileges (PAL/ILP), an AKC Canine Partners listing number or approved Foundation Stock Service (FSS) breeds are eligible to participate. Dogs with a Purebred Alternative Listing/Indefinite Listing Privileges (PAL/ILP) or an AKC Canine Partners listing number must be spayed or neutered in order to compete. Wherever the word "dog" is used in these regulations it includes both sexes.

Condition of the Dog. Dogs with physical challenges (including amputees) are eligible to participate provided that, in the opinion of the judge, they display no signs of physical discomfort and can safely complete the search. Dogs with bandages, sutures, or visible wounds are not eligible. Deaf dogs and blind dogs are allowed to enter. Dogs that are both deaf and blind are able to participate so long as the handler is in control of the dog at all times, the dog can complete the requirements of the class, and the dog does not appear to be under undue stress in the opinion of the judge.

ENTRY FEES PER CLASS

No entries will be accepted by phone, email, or fax. Hand Delivery will not be accepted in the first 24 hours after opening. Express mail entries must include the signature waiver allowing them to be left at the secretary's address. Inquiries may be directed to Carolyn Venaglia at SCKCtrialsecy@gmail.com. No entry shall be made and no entry shall be accepted which specifies any conditions as to its acceptance. Illegible entries will not be processed and will be returned to the exhibitor. Returned checks do not constitute a valid entry and the Trial Secretary will add a \$25.00 collection fee to the amount of each returned check.

WAIT LIST INFORMATION

Scott County Kennel Club is offering a wait list to fill openings created by withdrawn entries after the trial's closing date/time. A maximum of 50 entries per day will be placed on the club's wait list. All entries, including wait listed entries, must be received by the Trial Secretary prior to November 18,2020. No entries may be withdrawn with a refund after closing on November 18,2020. unless a withdrawn entry can be replaced by a wait listed entry, a full refund will be issued for the withdrawn entry. Any wait listed entry that does not move off the wait list into the trial will receive a full refund. `On the day of the trial, the club may assign entries for absent individuals to those on the wait list who are present at the trial site.

STAGING AREA, HANDLER'S BREIFING, AND WARM-UP INFORMATION

Staging Area will be out of view of search area(s). Staging area will include warm-up and waiting area.

The **Handler's Briefing** may take place in view of the search area provided that social distancing to a minimum of 6 feet apart is possible or the judge may provide individual briefing at the start line. In the Handler's Briefing the judge will explain if there's an offleash option, number of hides, maximum height of hides and maximum time for the search. NO DOGS are to be present during the Handler's Briefing.

A warm-up area the club shall designate a warm-up area. One labelled container per target odor being used in the trial on that day will be placed in the warm-up area. This will allow handler-dog teams to prepare themselves for the search prior to their run. Each team should limit their warm-up to two minutes or less so that others may be able to use the warm-up area as well. Clubs may also place blank containers.

SEARCH AREA AND RING CONDITIONS

Search areas may be of any shape, and of the size specified in the Regulations for each class.

Search Area Conditions. Searches may be indoors, on matted, carpeted, or tiled surfaces, or outdoors on grass, gravel, earth, concrete, or asphalt surfaces.

Search Area Sizes will be as required in the regulations AKC Scent Work.

ADDITIONAL SITE INFORMATION

Trial Site. It is not appropriate to scout the trial location prior to the trial date. Many search locations are real-life environments and such visits may risk the host losing the opportunity to use the location in the future.

Possession of Odors and Training. Chapter 5. Section 35 of the Scent Work Regulations state "No person other than those engaged in the administration of a trial shall be in possession of any target odor when on the trial grounds. There shall be no training on the grounds of the AKC Scent Work trial, other than the designated warm-up area".

Spectator Area. Only people entered in the trial can attend the trial. Any person not handling a dog in the current class, or any person who has already completed their run in the class may choose to watch the search from the spectator area. Handlers may not watch other exhibitors from their class prior to their run except in the case of Handler Discrimination classes. No one outside the search area may assist the handler or disclose the location of the hide. Spectators who intentionally or unintentionally give aid to a team may be ask to leave the area by the judge. Spectators are forbidden to discuss details of the search with handlers who have not run.

Crating space will be not be available in the building. All crating will be out of exhibitors' vehicles.

Exhibitors are responsible for cleaning up after their dog(s). Any exhibitor failing to do so may be excused without benefit of refund if the Event Committee deems the exhibitor to be in violation of this requirement. Cleaning supplies and disposal sites will be available at various locations around the show grounds.

COVID Information.

Scott County Kennel Club, the trial officials and participants are required to follow the State of Iowa and Scott County, Iowa guidelines that are in place at the time of the trial.

The trial will practice social distancing consistent with guidelines in place at the time of the trial.

All officials and participants will wear masks when in close proximity to others or in the building.

An update on COVID requirements will be included in the final confirmation letter.

High In Trial

Only teams who participate in the same difficulty level in all elements offered, except for Handler Discrimination, are eligible to win High in Trial. The High In Trial is determined by adding the team's faults across the elements. If there is a tie based on faults, then the team's times across the elements will be summed and the faster-finishing team will win.

Team winning High In Trial will earn rosette.

Claims will be arbitrated as set forth on the Official AKC Entry Form for this event.

NOTICE TO EXHIBITORS

SAFETY, BEHAVIOR and LIABILITY

The safety of the dog is our primary concern. By entering this trial, exhibitors acknowledge that they are familiar with the rules and regulations of this sport, and that their dogs are familiar with and able to perform all searches safely. It is expressly understood that exhibitors alone are responsible for the behavior of their dogs and/or children. Any exhibitor whose dogs and/or children create an unnecessary disturbance or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the trial committee, be asked to leave the show site. In such case, no refund of any fees paid will be made. The Scott County Kennel Club and its agents, employees, etc., will assume no responsibilities for any loss, damage or injury sustained by exhibitors or handlers, or to any of their dogs or property and further assumes no responsibility for injury to children. The Scott County Kennel Club reserves the right to decline entries for cause and may remove any dog on account of aggression. No one shall have any recourse or claim against the Scott County Kennel Club or any official thereof.

Collars, Leashes and Harnesses. During searches, dogs must wear a properly fitted collar or harness approved by the judge. A wearable camera such as a Go Pro may be mounted to the dog's harness, if desired. Leashes may be of any length and/or retractable. The leash should be made of plain, pliable material.

All dogs must be on leash at all times, and retractable leashes may not be used when on trial grounds (except during judged searches). Dogs must enter and exit the search area with the leash attached to the collar or harness, including when waiting in the search area before and after the search. An offleash option may be offered at the discretion of the judge, only if the area is completely enclosed.

REFUNDS

No entry fee will be refunded if the trial cannot open or be completed by reason of riots, civil disturbances, fire, an act of God, public emergency, act of a public enemy, or any other cause beyond the control of the organizing committee. No entry fee will be refunded in the event a dog is absent, disqualified, excused, or barred from competition by the action of the Trial Committee. Entry fees will be refunded in full if a written request (mail or email) is received by the trial secretary on or before the trial closing date. A full refund will be reimbursed to any entrant whose entry is replaced by a Wait Listed entry. The club will refund the entry fee minus \$5 per run for bitches unable to compete because they are in season if a written request and a certificate or letter from a veterinarian is received by the trial secretary prior to the start of judging. The club will issue a full refund of entries in the case of death or life-threatening illness of either dog or handler. The club will issue a full refund of entries in the event the trial is canceled due to COVID-19.

RINGSIDE

Judges are not required to wait for dogs. The Owner of each dog is solely responsible for having it ready at the search area when it is to be judged. The Club has no responsibility to provide service through a public address system or stewards or runners for the purpose of calling or locating dogs that are not brought into the ring when required.

EXHIBITOR CHECK-IN: At check-in you will receive your armband number. Once the time and location for check-in is determined all exhibitors will be notified by email.

Exhibitors MUST check-in EACH day they are entered.

"Exhibitors should follow their veterinarian's recommendation to assure their dogs are free of internal and external parasites, any communicable diseases, and have appropriate vaccinations."

AGREEMENT

I certify that I am the actual owner of the dog, or that I am the duly authorized agent of the actual owner whose name I have entered. In consideration of the acceptance of this entry, I (we) agree to abide by the rules and regulations of The American Kennel Club in effect at the time of this event, and any additional rules and regulations appearing in the premium list of this event and entry form and any decision made in accord with them. I (we) agree that the club holding this event has the right to refuse this entry for cause which the club shall deem sufficient. I (we) certify and represent that the dog entered is not a hazard to persons or other dogs. In consideration of the acceptance of this entry and of the holding of this event and of the opportunity to have the dog judged and to win prizes, ribbons, or trophies, I (we) agree to hold the AKC, the event-giving club, their members, directors, governors, officers, agents, superintendents or event secretary and the owner and/or lessor of the premises and any provider of services that are necessary to hold this event and any employees or volunteers of the aforementioned parties, and any AKC approved judge, judging at this event, harmless from any claim for loss or injury which may be alleged to have been caused directly or indirectly to any person or thing by the act of this dog while in or about the event premises or grounds or near any entrance thereto, and I (we) personally assume all responsibility and liability for any such claim; and I (we) further agree to hold the aforementioned parties harmless from any claim of loss, injury or damage to this dog.

From the North or Northeast, take US 61 or I-88 to I-80 West. Follow I-80 $\,$

West to I-280 East. Exit at Iowa Exit 4, West Locust Street. Turn right on West Locust and proceed one block to West Lake Boulevard. Turn right. Quad City Dog Center is at 2390 West Lake Boulevard, across from Honda plant.

From the East, take I-80 to I-74 to I-280 West. Follow I-280, crossing the Mississippi River. Exit at Iowa Exit 4, West Locust Street. Turn left on West Locust and proceed one block to West Lake Boulevard. Turn right. Quad City Dog Center is at 2390 West Lake Boulevard, across from Honda plant.
